9. Managing Committee of the school shall not increase fee during academic session without prior approval of the Director of Education which is mandatory under sub section (3) of section 17 of the DSEA & R 1973 and follow the instruction issued by the department for other dues.
10. That all the conditions of the rule 50 of DSEA & R shall be fulfilled and facilities under rule 51 of DSEA & R 1973 should be made available to the students.
11. That proof of the effect that qualified staff has been appointed as per RR's be provided for verification to the EO concerned.

19. That the school maintains high academic standards.
20. That the school abides the direction of Hon'ble Supreme court regarding transport.
21. That Recognition/ Upgradation subject to the fulfillment of condition of affiliation of CBSE and the school should not start Secondary / Sr. Sec. classes without Grant of affiliation by the Board concerned .
